



Dependable 10-Year Warranty KeedeRoll MT

Dependable KeedeRoll MT Limited Warranty Terms and Conditions:

Subject to the terms and limitations stated hereafter Dependable, LLC warrants that KeedeRoll MT will be free from manufacturing defects and will perform as described in the product data sheet for a period of 10 years from the date of purchase when the KeedeRoll MT is used and installed in accordance with the installation instructions laid out in the KeedeRoll MT product data sheets and installation guides at the time of installation.

This warranty includes “Residential” applications defined as single family detached residential dwellings; and “Commercial” applications defined to include installations in multi-family residential dwellings (e.g., apartments, condominiums, cooperatives, and timeshares). KeedeRoll MT installations in public places, commercial establishments and other applications may be afforded coverage under this Limited Warranty on a case by case basis as determined by the FloorPrep Technical Services Director. Projects not falling into the “residential” or “commercial” definitions above will require warranty approval in writing prior to installation.

Further, efflorescence is considered a natural occurrence with cementitious materials and is not considered to be a defective condition, and therefore is not covered under this warranty. It is the responsibility of the owner/builder/installer to ensure the suitability of all building materials and associated products for the owner’s intended use. Consultation with an experience professional installer is recommended.

Resolution: If the Keederoll MT fails to meet this warranty the owner’s exclusive remedy, and Dependable, LLC’s sole obligation, is, at it’s election, to: a) reinstall or replace the failed portion of the floor covering assembly or b) to pay an amount not to exceed the original square foot cost of the assembly deemed defective, including the purchase price of the Products, non-reusable floor setting materials and appropriate setting and grouting materials. Due to naturally occurring wear and tear of materials, Dependable, LLC cannot guarantee or warrant an exact match to the original tile, stone or other flooring materials used in the installation. In such events suitably similar materials should be used.

The Owner must provide proof of the defective Products, proof of purchase, the name and address of all installers and proof of the cost of installation. Dependable, LLC will only warrant with the above documentation and will not reimburse the Owner for any costs without written and submitted documentation. Without the above documentation this warranty has no legal effect. Dependable, LLC withholds the right to inspect the alleged defective area.
